

ARTICLES OF INCORPORATION

OF

Vestnik, Inc.

The undersigned desiring to form a Not For Profit Corporation under the Non-Profit Corporation Law of Florida, pursuant to Chapter 617, Florida Statutes (F.S.), do hereby certify:

Article I: This Corporation shall be named Vestnik, Inc.

Article II: The principal office of the Corporation is to be at
14944 Indigo Lakes Drive, Naples, FL 34119, USA

Article III:

A. Vestnik, Inc. is exclusively organized for charitable, educational, and scientific purposes. At Vestnik, Inc. no part of the net earnings will benefit any private individual, and the organization won't engage substantially in influencing legislation or political campaigns, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article hereof. Upon dissolution, assets will be distributed for exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, to the federal or state/local government for a public purpose, or to a court to be distributed to organizations organized and operated exclusively for such purposes.

B. Vestnik, Inc. is committed to serving Russian-speaking asylees across the United States who seek refuge and a new beginning. We understand the challenges faced by journalists, protestors, religious and ethnic minorities, members of the LGBTQ community, and other vulnerable individuals who have experienced heightened persecution. Our mission is to offer affordable, comprehensive legal services and guidance in immigration matters, ensuring equitable access to justice and the American dream. We strive to uphold the rights of our clients by enabling them to navigate the complex immigration system with expert support and dignity. Vestnik, Inc. will adhere to the principles of a non-profit organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

C. Additionally as part of its charitable outreach program Vestnik, Inc. plans to offer Pro-bono immigration services in certain cases, as well as regular free communications, educating the public on current trends and practices in immigration matters.

D. As circumstances and resources allow, Vestnik, Inc. plans to extend services enumerated in Paragraphs B & C of this Article and serve a wider demographic of vulnerable communities.


