ARTICLES OF INCORPORATION OF THE ROAD TO THE ARTS, INC.

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, acting as incorporator to form a corporation, adopts the following Articles of Incorporation.

Article One: The Name of the Corporation is

Article Three: The purposes for which the corporation is organized are as follows:

- (1) To conduct activities which are exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended:
- (2) To foster, promote and advance greater knowledge, understanding and appreciation of the arts; to encourage the creation, development and presentation of, and participation in, artistic activities and works and to disseminate such works through various means and venues.

- (3) To develop innovative and meaningful educational materials and to present these materials to the public.
- (4) To preserve, promote, and perpetuate art forms by presenting performances and creating educational programs concerning the arts
- (5) To sponsor workshops, training sessions, symposia, performances, installations, lectures and other cultural and educational endeavors.
- (6) To conduct any and all activities as shall from time to time be found necessary, appropriate or proper in connection with or incidental to any of the foregoing and as are lawful for a not for profit corporation.

Article Four:

- (1) Notwithstanding any other provision of these articles, the Corporation is organized exclusively for charitable purposes, as specified in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
- (2) The Corporation is not formed for pecuniary profit or for financial gain and no part of its assets, income or profit shall be distributed to or inure to the benefit of any private individual. Reasonable compensation, however, may be paid for services rendered to or for the Corporation in furtherance of one or more of its purposes.
- (3) No part of the activities of the Corporation shall be devoted to carrying on propaganda or otherwise attempting to influence legislation except to the extent authorized by Internal Revenue Code section 501(h), as amended, or the corresponding provision of any future United States Internal Revenue Law, during any fiscal year or years in which the Corporation has chosen to utilize the benefits authorized by the statutory provision, and the Corporation shall not participate in or intervene, including the publishing or distribution of statements, in any political campaign on behalf of any candidate for public office.

(4) In the event of dissolution, the assets and property of the Corporation remaining after payment of expenses and the satisfaction of all liabilities shall be distributed for the nonprofit purposes of the corporation and/or to such charitable, educational or scientific organizations as are qualified under section 501(c)(3) of the Internal Revenue Code of 1986, as amended, in accordance with an order approved by a Court of competent jurisdiction.

Article Five: The period of duration is perpetual.
