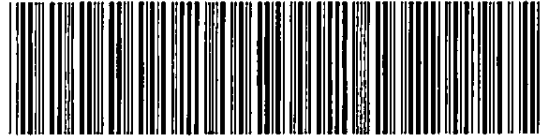

ARTICLES OF INCORPORATION

SECTION 1: ARTICLES OF INCORPORATION of the undersigned, a majority of whom are citizens of the United States, desiring to form a Florida Not-For-Profit Corporation under Florida Statute Ch. 617, et seq., do hereby certify:

FIRST: The name of the corporation shall be: Keys Accountability Project Inc.

SECOND: The place in the State of Florida where the principal office of the corporation is to be located is 1532 Shaw Dr, Key Largo, FL 33037, Key Largo, Monroe County.

The Mailing address is P.O. Box 252, Tavernier, FL 33070.

THIRD: Keys Accountability Project Inc. is a non-profit organization.

The mission of Keys Accountability Project Inc. is to press for a smaller, more responsive government that focuses on fundamental obligations — safe neighborhoods, prompt action on urgent resident-identified issues, and elimination of the non-essential.

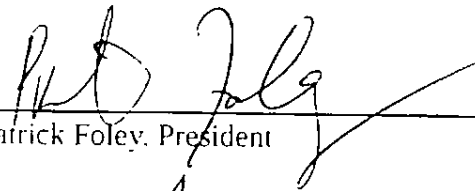

FIFTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay set forth in Article Third hereof. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or the corresponding section of any future federal tax code.

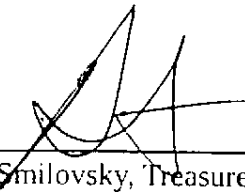

SIXTH: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s), as said court shall determine which are organized and operated exclusively for such purposes.

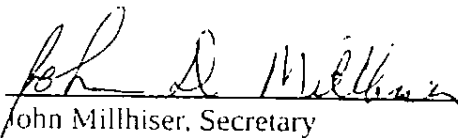
