ARTICLES OF INCORPORATION OF SOYMAS FOUNDATION, INC.

In compliance with the requirements of F.S. Chapter 617 (Florida Not for Profit Corporation Act), the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit corporation.

ARTICLE I. NAME

The name of the corporation shall be:

On liquidation or dissolution all properties and assets of this corporation remaining after paying or providing for all debts and obligations shall be distributed and paid over to a fund, foundation or corporation organized and operated for charitable purposes designated by the board of directors which shall at the time qualify as a tax-exempt organization under Internal Revenue Code §501(c)(3), or as that statute may be amended.

The corporation shall be managed by a Board of Directors. The Directors shall be dely cleeted in the manner stated in the Bylaws of the corporation.
