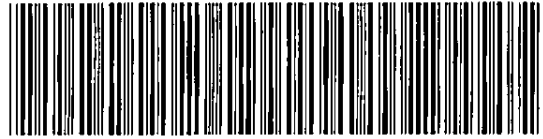

**ARTICLES OF
INCORPORATION**

**ARTICLE I
NAME**

The name of this corporation shall be Jensen Beach Church & School at Debauche, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

The principal street and mailing address is: 2163 NE Pine Ridge St. Jensen Beach, FL 34957.

**ARTICLE III
PURPOSE**

Jensen Beach Church & School at Debauche, Inc. is a non-profit corporation and shall operate exclusively for religious, educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. The corporation is organized to support the existing church and school in Debauche, Haiti that was founded in the year 2000 by First Baptist Church of Jensen Beach. Support to include, but not limited to:

1. the funding of the church staff, the school staff, and the maintenance staff.
2. the necessary supplies for church, school and maintenance.
3. Food supplies for school children's meals.
4. Medical supplies

ARTICLE IV
MANNER OF ELECTION

4.01 Manner of Election

ARTICLE VI
LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VII **DISSOLUTION**

Upon termination or dissolution of the corporation, any assets lawfully available for distribution shall be distributed to one (1) or more exempt purposes within the meaning described in Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
