This corporation is founded exclusively for charitable purposes within the meaning of the IRS Code Sec 501(c)(3); namely: To inform, educate and inspire persons of all ages located in South Florida concerning the rich history, culture, and the daring innovations that contributed to the sport of BMX Biking in Florida. It will preserve and celebrate the heritage of BMX Biking by maintaining exhibits of related artifacts, as well as archives of text, schematics and photographs. It will research the lives of the pioneers and inventors who contributed to the sport on the material level, the technical level and by popularizing it. It will also offer classes, both in person and online, in bike riding, riding safety, and on the importance of physical fitness in general. It will help organize bike riding clubs and foster opportunities for competition. Through exhibitions, education, and community engagement it will inspire and empower future generations of riders while honoring the pioneers and enthusiasts who have shaped the sport. Likewise, it will carry out any additional activities that are seen by the directors to be in furtherance of the above stated purposes and objectives.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable purposes. It will not attempt to influence legislation or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered, for work done, resources purchased or properties acquired that are seen by the directors to be in furtherance of its exempt purposes.
