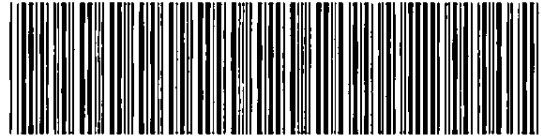

## E. Continued

Purpose and Dissolution Clause as required by IRS:
