

Dear Ms. Lovelace,

My name is John Terwilliger, and I am the new treasurer of the Zeta Sigma Alumni Association (ZSAA), we have been a registered entity with the Department of Agriculture and Consumer Services (DACS) since 2008. In the process of changing the signature card at our bank last month, we were told that we needed to have the entity registered with the Secretary of State via Sunbiz in order to make the change. With the information that was provided to me I registered ZSAA as an LLC on the Sunbiz on-line registration. After doing that I was told by the bank that ZSAA is a non-profit voluntary association and not an LLC, so I needed to correct the error. It was my understanding that I could not make any changes to an existing Sunbiz entity, so I entered a new registration for ZSAA as a non-profit corp. After applying for a new registration, I received information from Sunbiz that my new entity registration ZSAA non-profit Corp was too closely worded to another listed entity (Tracking# 600425220496). In order to fix that I dissolved ZSAA LLC on the website and received confirmation of that event. I have attached to this packet all of the emails and notices sent to me concerning this problem.

Through this notarized declaration I am voluntarily dissolving the Department of State entity of Zeta Sigma Alumni Association LLC (Doc# L24000095269) that was registered in error.

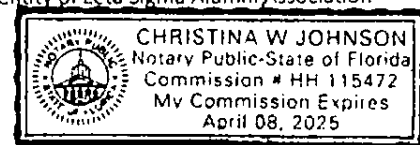




