#### ARTICLE I

- 5. To acquire and receive by purchase, donation or otherwise, any real, personal, or mixed property, and to hold, use and dispose of the same in furtherance of any or all the objects and purposes of the corporation.
- To borrow money and to issue evidence of indebtedness in furtherance of any
  or all the objects of its business, and to secure loans by mortgage, pledge,
  deed of trust, or lien.
- 7. To solicit funds and donations in kind to further the purposes of this corporation.
- 8. To apply for, obtain and contract with any federal, state, or local government or agency for the direct loan or loans or other financial aid in the form of grants or otherwise relating to the purposes of this corporation.

#### ARTICLE VIII
