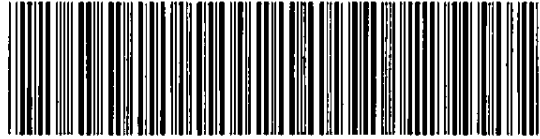

ARTICLES OF INCORPORATION  
In compliance with Chapter 617, F. S., (Not for Profit)

Articles of Incorporation of the undersigned, who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I

The name of the corporation shall be Divine Mercy Divina Misericordia, Inc, hereinafter referred to as the "corporation".

ARTICLE II

The initial street address of the principal office of this corporation in the State of Florida is: 1945 7<sup>th</sup> Dr SW, Vero Beach, FL 32962. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This corporation shall have two(2) directors initially. These directors shall hold office until the first annual meeting or until their successors are elected or appointed and qualified as provided in the By-Laws. The number of directors may be increased or diminished from time to time, as provided in the By-Laws.

#### ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal revenue Code, or the corresponding section of any future federal tax code.




