**ARTICLES OF CORRECTION
TO ARTICLES OF INCORPORATION
OF
FRIENDS OF BCC MEDIA, INC.**

Pursuant to the provisions of Section 617.0124 of the Florida Statutes, the undersigned Authorized Representative hereby makes, acknowledges and files Articles of Correction within 30 days of the filing date of the Articles of Incorporation of Friends of BCC Media, Inc. (the "Corporation"):


1. The Articles of Incorporation of Friends of BCC Media, Inc. were filed with the Florida Department of State on March 20, 2024, under File No. N24000003664.

2. The Articles of Incorporation contained an incomplete purpose statement (the "Purpose") of the Corporation and the Corporation desires to correct the Purpose of the Corporation.

3. The Articles of Incorporation are corrected by deleting the FOURTH Paragraph in its entirety and substituting therefore the following:

FOURTH: Purpose. The Corporation is organized and shall be operated exclusively for charitable, religious, scientific and/or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Such purposes shall include but shall not be limited to: empowering churches, prison ministries, schools, and individuals globally to make accessible the message of the Bible, particularly to children and youth worldwide, in a contemporary and age-appropriate manner by supporting, accelerating and expanding new and existing educational media projects focused on bringing the Bible to life through technology and digital media, including specifically providing financial support to BCC Media STL, a leading worldwide non-profit that produces and distributes content with positive and Christian values in association with Brunstad Christian Church based in Norway, and any and all related charitable purposes. The Corporation may do any other act or thing incidental to or connected with the foregoing purposes, or in the advancement thereof, but not for the pecuniary profit or gain of its members, directors, advisors or officers, except as permitted under the Act. In furtherance of its corporate purposes, the Corporation shall have all general powers enumerated in the Act, or any successor provisions thereto.
