Article 1: The name of the corporation shall be: ICC GLOBAL INSTITUTE INC.


Article 2: The Place in this state where the principal office of the Corporation is to be initially located is the 10 FAIRWAY DRIVE, STE 219 City of DEERFIELD BEACH, PALM BEACH County FLORIDA.

Article 3: Said corporation is organized to provide for the physical, intellectual, and emotional needs of underprivileged and disadvantaged people around the world through partnerships and direct development opportunities. The Institute primary focus will be partnering with educational organizations in depressed communities also developing our own opportunities to such communities, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is organized to support qualified groups and individuals, including others non-profit organizations.

Article 5: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.


Article 6: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a

public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.




