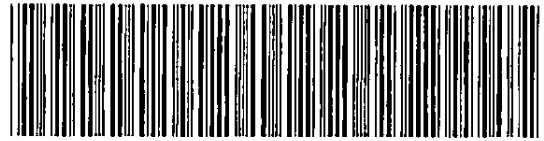

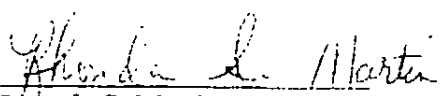

Name: OPM Connection Church, Inc. ("the Corporation").

1. The street address and mailing address of the Corporation is 2032 Benedict Rd, Jacksonville, FL (32209) and PO Box 12074, Jacksonville, Florida, (32209), respectively.
2. The purposes for which the Corporation is organized are to operate a Church, one or more, conduct religious services, and maintain spiritual programs for the benefit of its parishioners, including pastoring, Biblical teaching, and counseling, and to have and exercise all powers as permitted by state and federal law including IRC s.501(c)(3), to effect any and all of the foregoing.
3. Directors. There shall never be less than 3 directors, and the method of their election, including terms of service, will be stated in the bylaws of the Corporation. The directors shall also constitute to members of the Corporation.
4. Resident Agent. The initial registered office of the Corporation will be 1912 Hamilton Street, Suite 203, Jacksonville, Florida, 32210 and the initial registered agent at that address will be Rhonda S. Martin who acknowledges such appointment by signing her acceptance below.

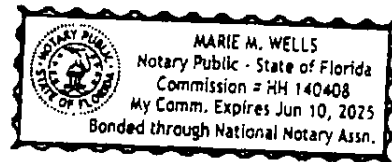
