ARTICLES OF INCORPORATION

OF

GET REDD FOUNDATION CORP. (a Florida Not-For-Profit Corporation)

Pursuant to the provisions of Section 617.0202 of the Florida Not for Profit Corporation Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

ARTICLE I

NAME

The name of this corporation is Get Redd Foundation Corp. (the "Corporation").

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is 7565 SW 190 Street, Cutler Bay, Florida 33157.

ARTICLE III

PURPOSE

The Corporation is established not for pecuniary profit or financial gain. The Corporation shall be a not for profit corporation under the Florida Not for Profit Corporation Act and is irrevocably dedicated to and operated exclusively for non-profit purposes. The purposes for which the Corporation is organized are exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or any successor thereto) ("Code Section 501(c)(3)"), specifically: to provide a creative space for processing experiences and emotions related to rare blood disorders and other diseases through choreography, dance expression, and other means; to raise awareness; and to fund research. Through dance, the Corporation aims to empower individuals to share their unique stories and express their struggles and triumphs, fostering a sense of community and understanding. The Corporation may engage only in activities permitted under Florida and United States laws that further its exempt purposes. It may promote, establish, conduct, and maintain activities on its own behalf and contribute to or assist other corporations, organizations, and institutions carrying on exempt activities?

ARTICLE IV

POWERS.

The Corporation hereby incorporates by reference any and all corporate powers given to corporations not for profit by virtue of Section 617.0302 of the Florida Not for Profit Corporation Act. The Corporation's activities are limited by any and all restrictions that are required to obtain tax exempt status under Code Section 501(c)(3). No substantial part of the assets or the net earnings of the Corporation shall inure to the benefit of, nor be distributed to, any officer or director of the Corporation, or to any other private person, in such a fashion as to constitute an application of funds not within the purpose of a charitable organization described in Code Section 501(c)(3). However, reimbursement for expenditures or the payment of reasonable compensation for services rendered to the Corporation shall not be deemed to be a distribution of earnings or assets.

ARTICLE V

MEMBERS

The Corporation shall not have any members.

ARTICLE VI

INCORPORATOR

ARTICLE VII

BOARD OF DIRECTORS: OFFICERS

The business affairs of the Corporation shall be managed and all the corporate powers thereof shall be vested in and exercised by a Board of Directors. The Board of Directors shall be appointed as provided in the Bylaws of the Corporation, which the Board of Directors shall adopt. The initial Board of Directors shall consist of three (3) persons, who shall be Liudmila Esquerdo, Vianca Natalie Perez and Ivette Esquerdo. The directors of the Corporation shall serve until their successors are duly qualified and elected as provided in the Bylaws of the Corporation or their earlier death, resignation or removal in accordance with the Bylaws of the Corporation. The number of directors that constitutes the Board of Directors may be increased or decreased as provided in the Bylaws of the Corporation; provided, however, that in no event shall the number of directors be less than three (3).

The Corporation shall have a President, Secretary and Treasurer and may have such other officers, including one or more Vice Presidents, and assistant officers as the Board of Directors may determine in accordance with the Bylaws of the Corporation. The officers of the Corporation shall be appointed by the Board of Directors and shall serve until their successors are duly qualified and elected as provided in the Bylaws of the Corporation or their earlier death, resignation or removal in accordance with the Bylaws of the Corporation. The initial officers of the Corporation are Liudmila Esquerdo – President; Vianca Natalie Perez – Secretary; and Ivette Esquerdo – Treasurer.

ARTICLE VIII

AMENDMENT

These Articles of Incorporation may be amended as provided in the Bylaws of the Corporation.

ARTICLE IX

DISSOLUTION

In the event of the complete or partial liquidation or dissolution of the Corporation, whether voluntary or involuntary, the balance of all money and other property received by the Corporation from any source, after the payment of all debts and obligations of the Corporation, shall be used or distributed as provided by law to one more or charitable organizations described in Code Section 501(c)(3), as selected by the Board of Directors.
