

## ATTACHMENT TO ARTICLES OF INCORPORATION NOT FOR PROFIT CORPORATION OF COASTAL YACHT DONATIONS, INC.

## ARTICLE III. PURPOSE.

COASTAL YACHT DONATIONS, INC. (the "Corporation") is incorporated pursuant to the Florida Not for Profit Corporation Law Chapter 617. F.S. The purposes for which the Corporation is organized and shall be operated are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") or the corresponding section of any future federal tax code (Code).

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Florida upon not for profit corporations, including, but without limitation thereon, to receive gifts, bequests and contributions, in any form, and louse, apply, invest and reinvest the principal and/or income therefrom or distribute the same for the above purposes.

### ARTICLE IX ADDITIONAL PROVISIONS.

- A. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any private persons or interests, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes herein set forth.
- B. It is intended that this Corporation shall have, and continue to have, the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) thereof, and these Articles of Incorporation shall be construed accordingly, and all powers and activities hereunder shall be limited accordingly.
- C. No substantial part of the Corporation's activities shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.
- D. Upon the dissolution or liquidation of the Corporation, its Board of Directors, after paying or making provisions for payment of all known liabilities of the Corporation, shall distribute the Corporation's property and assets exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Code. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization(s), as said Court shall determine, which are organized and operated exclusively for such purposes.
