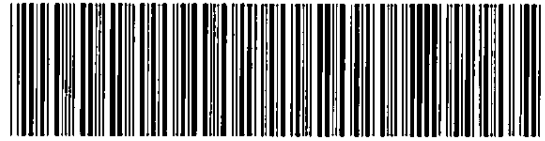


## Articles of Domestication
