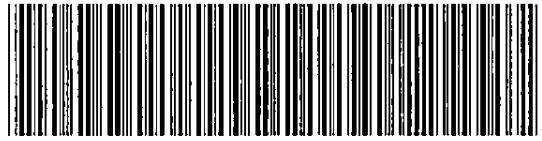

RTDM's mission is summarized by the following bible scriptures (a) Isaiah 37: 31 [God said] And the surviving remnant of the house of Judah shall again take root downward and bear fruit upward. (b) Matthew 28: 19 – 20 [Jesus said] 'Therefore go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely I am with you always, to the very end of the age. (c) Proverbs 22: 6 [God said] Train up a child in the way he should go, and when he is old he will not turn from it. (d) Isaiah 54: 13 [God said] All your children shall be taught by the Lord, and great shall be the peace of your children.

RTDM's mission also entails training up other ministers and personnel to minister at the initial registered office of the Corporation and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of the Corporation and the achievement of its purpose within the State of Florida and elsewhere.
