ARTICLES OF INCORPORATION FOR FAYGIN LANE MAINTENANCE ASSOCIATION, INC.

The undersigned hereby submits these articles for the purpose of forming a not-for-profit corporation under Chapter 617.02011, Florida Statutes, and certifies as follows:

ARTICLE | Corporate Name

The name of the corporation is Faygin Lane Maintenance Association, Inc., hereinafter called the "Association."

ARTICLE (I Address

The mailing address for the Association is 16121 Lee Road, Suite #101, Fort Myers, FL 33912. The principal office of the Association shall be located at the mailing address or at such other place as may be subsequently designated by the Board of Directors of the Association.

ARTICLE III Purpose and Powers of the Association

The Association does not contemplate pecuniary gain or profit to the Members thereof and shall make no distribution of income to its Members, Directors, or Officers. The specific purposes for which it is formed are to provide for maintenance, preservation, and control of the Components and Common Areas (as defined in the Declaration of Covenants, Easements, and Restrictions for Faygin Lane, referred to hereinafter as the "Declaration"), and related improvements, according to the provisions of the Declaration, and to promote the health, safety, and welfare of the Members of the Association which may also be known as the Faygin Lane Property, and any additions thereto as may hereafter be brought within the jurisdiction of this Association for this purpose.

The Association shall have all powers granted under Section 617,0302, Florida Statutes and Chapter 720, Florida Statutes, including but not limited to:

- a. To exercise all of the common law and statutory powers of a corporation not for profit and property association organized under the laws of the State of Florida that are not in conflict with the terms of the Declaration, these Articles, or the By-Laws of the Association.
- b. To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in the Declaration as the same may be amended from time to time, said Declaration being incorporated herein by reference as if set forth in its entirety.
- c. To fix, levy, collect, and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all other expenses incident to the conduct of the business of the Association including

but not limited to all licenses, taxes, or governmental charges levied or imposed against the property of the Association.

- d. To maintain, repair, and operate the property of the Association,
- To purchase insurance upon the property of the Association and insurance for the protection of the Association and its Members.
- f. To reconstruct improvements after casualty and make further improvements upon the Property.
- g. To enforce by legal means the provisions of the Declaration, the Articles of incorporation and By-Laws of the Association, and any Rules and Regulations adopted pursuant thereto.
- To employ personnel to perform the services required for the proper operation of the Association.
- i. To acquire (by gift, purchase, or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use, or otherwise dispose of real or personal property in connection with the affairs of the Association.
- i. To sue and be sued...
- k. To contract for the management and maintenance of Faygin Lane, and any property or easements and related improvements that are dedicated to the Association by plat or separate instrument, including any agreement or easement which imposes maintenance obligations on the Association, and to delegate any powers and duties of the Association in connection therewith except such as are specifically required by law or by the Declaration, these Articles or the Bylaws to be exercised by the Association's Board of Directors or the Members.

ARTICLE IV Membership

Section 1. <u>Membership generally:</u> No person except a Member admitted by the Association or the Declarant, as such terms are defined in the Declaration, is entitled to membership in the Association; and all Members and Declarant, regardless of whether Declarant is also a Member, shall be either Class A or Class B Members of the Association, as provided in this Article.

Section 2. <u>Class A Membership</u>: Until termination of Class B membership as provided in Section 3 of this Article, every Member who holds title to a Parcel (as defined in the Declaration) that is subject to assessment under the Declaration, except Declarant, shall be a Class A Member of the Association. Each Class A membership shall be appurtenant to a parcel of land. At the discretion of the Board of Directors, in the event a Member owns more than one Parcel, such Member may be required to hold more than one Membership with a Membership issued for each such Parcel to which the owner holds record title. If more than one person holds an interest in any Parcel, all such persons shall be Members; provided however, that only one (1) vote shall be cast with respect to any one (1) Parcel. No person other than a Parcel Owner may be a Class A Member of the Association, and a Class A membership may not be transferred except by a transfer of record title to the Parcel to which it is appurtenant.

Section 3. <u>Class B Membership:</u> The Declarant, or Declarant's successor and assigns, shall be a Class B Member of the Association unless and until Declarant or his successor and assignes resigns.

ARTICLEV Voting Rights

Section 1. Class A Voting: All Class A Members shall be entitled to one (1) vote for each Parcel owned. If more than one (1) person holds record title to a Parcel, there shall be only one vote cast with respect to such Membership, exercised as the holders of such Class A Membership determine among themselves.

Section 2. Class B Voting: The Class B Member(s) shall be entitled to appoint all members of the Board and all Association officers. The Class B Member(s) shall have two (2) times the number of votes held collectively by all Class A Members, plus one (1) vote.

ARTICLEVI Board of Directors

The affairs of this Association shall be managed and governed by a Board of Directors consisting of a minimum of three (3) Directors who need not be Members of the Association. The number of Directors may be changed by amendment of the By-Laws of the Association.

ARTICLE VII Bylaws

The Bylaws of the Association shall be adopted by the Board of Directors and may be altered, amended, or rescinded in the manner set forth in the Bylaws.

ARTICLE VIII Dissolution

In the event that the Association is dissolved, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed, and assigned to any nonprofit corporation, association, trust, or organization to be devoted to such similar purposes.

ARTICLE IX

The term of the Association shall be perpetual.

ARTICLEX Amendments

Amendments to the Articles of incorporation shall be proposed and adopted in the following manner:

Section 1. <u>Notice:</u> Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is to be considered.

Section 2. <u>Vote</u>: A resolution for the adoption of an amendment may be proposed by the Board of Directors or Members. Except as elsewhere provided, such resolutions must be adopted by no less than a majority of the votes present in person or by proxy at a meeting called for that purpose at which a quorum is present. Notwithstanding the foregoing, amendments may be adopted by the Declarant without consent of any Member.

Section 3. Limits on Amendments: No amendment shall make any changes in the qualifications for membership, or in the voting rights of Class A or Class B Members, without approval in writing by all Members. As long as a Declarant owns a Membership, no amendment shall be effective without the prior written consent of the Declarant, which consent may be withheld in the Declarant's sole discretion; provided, further, that regardless of whether the Declarant owns a Membership, no amendment shall be effective if it affects the Declarant's rights or alters any provision made for the Declarant's benefit

Section 4. <u>Certification:</u> A copy of each amendment shall be certified by the Secretary of

ARTICLE XI Indemnification

To the fullest extent permitted by Florida law, the Association shall indemnify and hold harmless every Director and every officer of the Association against all expenses and liabilities, including attorney's fees, actually and reasonably incurred by or imposed on him in connection with any legal proceeding (or settlement or appeal of such proceeding) to which he may be made a party because of his being, or having been, a Director or officer of the Association. The foregoing right to indemnification shall not be available if a judgment or other final adjudication establishes that his actions or omissions to act were material to the cause adjudicated and involved:

- a. Willful misconduct or a conscious disregard for the best interests of the Association, in a proceeding by or in the right of the Association to procure a judgment in its favor.
- b. A violation of criminal law, unless the Director or officer had no reasonable cause to believe his action was unlawful or had reasonable cause to believe his action was lawful.
- c. A transaction from which the Director or officer derived an improper personal benefit.
- d. Recklessness, or an act or omission which was committed in bad faith or with malicious purpose or in a manner exhibiting wanton and willful disregard for human rights, safety or property, in an action by or in the right of someone other than the Association or a member.
- Wrongful conduct by Directors or officers appointed by the Declarant, in a proceeding brought by or on behalf of the Association.

In the event of a settlement, the right to indemnification shall not apply unless a majority of the disinterested Directors approve the settlement as being in the best interest of the Association.

The foregoing rights of indemnification shall be in addition to, and not exclusive of, all other rights to which a Director or officer may be entitled.
