# ARTICLES OF INCORPORATION OF RHONDA FOR FLORIDA Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the corporation shall be: RHONDA FOR FLORIDA Inc.

### ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: 527 CANDIDATE COMMITTEE - NO MEMBERS

PURPOSE. (a) The Corporation is organized and shall be operated exclusively as a not for profit political organization within the meaning of Section 527 of the United States Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States internal revenue law) (the "Code") and for such related purposes as may be permitted to political organizations which are organized under the Florida Nonprofit Corporation Code and which are described in the aforesaid provision of the Code. (b) No person who is serving or has served as a member of the Board of Directors shall have any liability to the Corporation for monetary damages for any action taken, or any failure to take any action, as a member of the Board of Directors, except liability: (i) for any appropriation, in violation of his or her duties, of any business opportunity of the Corporation; (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (iii) for the types of liability set forth in the Florida Nonprofit Corporation Code; or (iv) for any transaction from which such person derived an improper personal benefit. The limitation of liability conferred in this Article shall be in addition to and not in lieu of all other limitations, immunities, and indemnities conferred by law, these Articles, and the Bylaws of the Corporation.
