Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: For current and prospective homeschool families. Through the utilization of a customizable calendar that's full of diverse events and opportunities we offer a supportive community, endless learning possibilities and socialization for the whole family. We're geared towards creating a stable environment that enables childen to build life long friendships in an all inclusive atmosphere.
