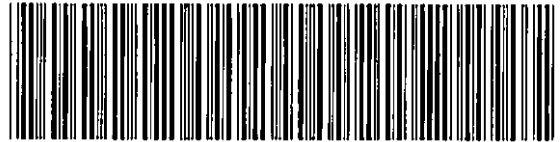

### ARTICLE III

The specific purpose for which this corporation is organized is: to teach and preach the Word of God.

To have the right to engage in religious, educational and benevolent work. The purpose of the Corporation is organized are exclusively for charitable, cultural, religious, scientific, literary and educational within the meaning of section 501c3 of the Internal Revenue Law.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, State, or Local Government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent Jurisdiction, in the County in which the principal office of the organization is then located, exclusively for such purposes.

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered.


