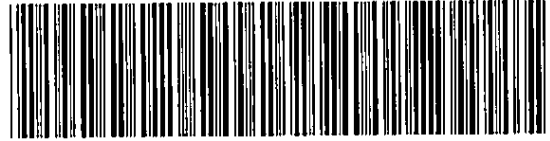

ARTICLE III : The purpose of our Non-Profit Home Improvement Company is to enhance the quality of life for individuals and families by providing affordable, safe and sustainable home solutions. Our corporation is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code.

Replace Article VIII with: NON-PROFIT DISSOLUTION OF TAX-EXEMPT ORGANIZATION: Upon the dissolution and winding up of the organization after paying or adequately providing for the debts and obligations of the organization the remaining assets shall be distributed to a non-profit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code of 1986 and which has established its tax-exempt status under that section or corresponding section of any future federal tax code; or shall be distributed to federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located to such organization or organizations as said Court shall determine, and which are organized and operated exclusively for such purpose.

ADD Article IX AMENDMENT OF ARTICLES :

These Articles may be amended, altered, or rescinded by a majority vote of the Board of Directors present at a regular or special meeting of the corporation, provided all notice and quorum requirements are met.
