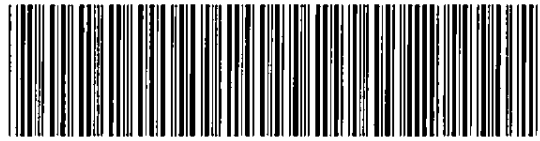

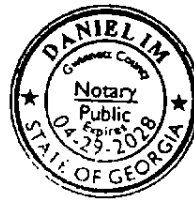

Article I - Name

The name of the Corporation shall be:

Article III - Purpose

The Corporation is organized exclusively for charitable, religious, and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purpose of the Corporation is to foster a community-driven ethical marketplace where trust is the foundation of buyer and seller interactions.
