ARTICLES OF INCORPORATION JC MIGLIORI FOUNDATION CORP.

NONPROFIT ARTICLES OF INCORPORATION ARTICLE I: NAME

1.01 The name of this corporation shall be JC MIGLIORI FOUNDATION CORP. The business of the corporation may be conducted as JC MIGLIORI FOUNDATION CORP.

NONPROFIT ARTICLES OF INCORPORATION ARTICLE II: DURATION

2.01 The period of duration of the corporation is perpetual.

NONPROFIT ARTICLES OF INCORPORATION ARTICLE III: PURPOSE

- 3.01 JC MIGLIORI FOUNDATION CORP. is a non-profit corporation and shall operate exclusively for autism and charitable purposes
- 3.02 JC MIGLIORI FOUNDATION CORP. is designated as a public benefit corporation.

NONPROFIT ARTICLES OF INCORPORATION ARTICLE IV: NON-PROFIT NATURE

This corporation is organized exclusively for charitable purposes within the meaning of Section 50l(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 50l(c)(3) exempt organizations. To this end, the corporation shall:

Be a Private School & therapy center for children diagnosed with ASD (Autism Spectrum Disorder), special needs & behavioral disorders. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

4.01 No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section S01(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation,

nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation.

- 4.02 No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
- 4.03 Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
- 4.04 The corporation shall not lend any of its assets to any officer or director of this corporation or guarantee to any person the payment of a loan by an officer or director of this corporation.
