

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows Heart of the Father Family reconnects & reconciles families to God first and then to each other. Through the unashamed gospel of Jesus Christ, we will utilize preaching, teaching, outreach, missions, life groups, discipleship, family ministries.
