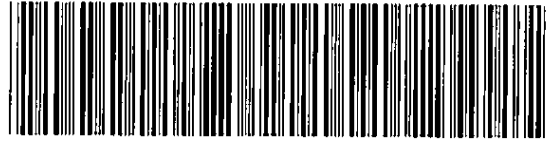

**Articles of Incorporation**  
**The Friendship Outreach And Community Education Foundation, Inc.**  
**(A Florida Not for Profit Corporation)**

The undersigned, acting as the incorporator of a not for profit corporation under the Florida Not for Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation:

**Article I: Name**

The name of the corporation shall be The Friendship Outreach And Community Education Foundation, Inc. hereinafter referred to as "the Corporation."

**Article II: Principal Office and Mailing Address**

The Principal office of the Corporation and the mailing address is 2030 Palm Avenue, Fort. Myers, FL 33916.

**Article III: Duration**

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

**Article IV: Purposes**

The Corporation is organized and operated exclusively for charitable, scientific, literary, community and educational purposes, including but not limited to those specific and general purposes listed below, within the meaning of Section 501 (c) (3) of the Internal Revenue Code, as amended.

A. The specific and primary purposes are:

1. To provide meaningful educational opportunities and experience through scholarship, college visitation and recruitment fairs for students in underserved communities in Lee County.
2. To provide information and services regarding issues that impact the social and economic position of citizens in underserved communities in Lee County.
3. To provide youth and adults in underserved communities, in Lee County, with opportunities to develop leadership skills.

B. The general purposes and powers are to have and exercise all rights and powers conferred on corporations formed under the Florida Not For Profit Act, provided, however, that the Corporation shall not, except to an unsubstantial degree, engage in any activities or exercise any powers that are not in furtherance thereof.
