ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Justice For Srila Prabhupada Foundation Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSES

The specific purposes of the Foundation will be:

- 1) To uncover, establish, and reveal the truth behind the suspicious circumstances of Srila Prabhupada's unnatural physical departure in 1977 and seek justice for him;
- 2) To initiate the legal process for the investigation into the homicidal death of Srila Prabhupada by police/government investigative agencies in India, and other countries, as necessary; give full cooperation and support to the said investigation; ensure that a free, fair and unbiased investigation is conducted at the highest level by experts in order to legally, forensically, and scientifically determine the facts regarding the homicidal poisoning of Srila Prabhupada that led to his death in 1977;
- 3) To work towards the identification, prosecution, and conviction of those person(s) who were directly or indirectly involved in causing the unnatural death of Srila Prabhupada by poisoning him, as well as those who have aided, abetted, concealed, or tampered with the evidence or in any way covered up or sabotaged the reporting of the case, related to the homicidal death of Srila Prabhupada under the criminal justice system of India, and other countries, as needed;
- 4) To take steps and exercise civil remedy against the persons responsible for the unnatural death of Srila Prabhupada in order to make them pay damages and compensate for causing irreparable and huge loss to Srila Prabhupada, his followers, well-wishers, and supporters, and to Lord Krishna's devotees and all humankind;
- 5) To work towards exposing the role of persons/groups of persons/organizations who have harbored and given undue protection to the persons responsible for the unnatural death of Srila Prabhupada, by constantly denying the foul play relating to the death of Srila Prabhupada, and who extensively endeavored to cover up this most heinous crime; to sue them and make them pay for their misdeeds and illegal actions and omissions.
- 6) To strive towards and work for initiating the enquiry/investigation by the concerned authorities into the child sexual abuse/molestation at the gurukulas/schools run by ISKCON, and work for the prosecution of the people connected with ISKCON involved

in child sexual abuse/molestation in any way, including their involvement in not responsibly reporting the commission of sexual offence to governmental authorities;

- 7) To work towards creating child abuse awareness in ISKCON and its affiliated institutions, and to educate the children about their legal rights against any kind of abuse in order to make them less vulnerable to sexual abuse:
- 8) To work towards freeing ISKCON from all deviant practices and activities conducted by its leaders and officers, and earnestly strive and work for the major overhaul of the ISKCON Governing Body Commission (GBC) and other institutions affiliated with ISKCON, in order to restore its democratic setup and ensure that it maintains the highest standards of purity, and functions in accordance with the wishes, directions, thoughts, and teachings of Srila Prabhupada, its founder.
- 9) To work towards stopping the misuse of the funds, properties, and assets of ISKCON, and affiliated organizations, by any of the organization's leaders, officers, and members; to clearly determine the responsibilities of the persons involved in the same, and to take appropriate action against them;
- 10) To welcome and invite back those sincere followers of Srila Prabhupada who were exiled from Srila Prabhupada's ISKCON, and its affiliated organizations, because of voicing their honest and valid concerns, and who were ostracized and vilified due to not following the corrupted policies, dictates, and commands of those in leadership positions.
- 11) To promote the printing of Srila Prabhupada's voluminous transcendental literatures on Vedic science, culture, and philosophy; distribute Krishna Prasad (spiritualized food); and support and energize the programs and projects of ISKCON and affiliated organizations; to serve all efforts that are aligned with the teachings of Srila Prabhupada, all founded in the Vedas, and to deliver the Krishna Consciousness Movement to every person in this world.
- 12) To reestablish and exponentially expand the glories and accomplishments of Srila Prabhupada, the greatest Vedic scholar of the age, and a pure representative of Sri Krishna. specially empowered to spread love of God and give Krishna consciousness, and peace and prosperity, to the world.
- 13) To engage in all activities necessary, useful or expedient, through operative measures permitted by the Florida Not For Profit Corporation Act and Section 501 (c)(3) of the Internal Revenue Code to promote the above mentioned purposes.
