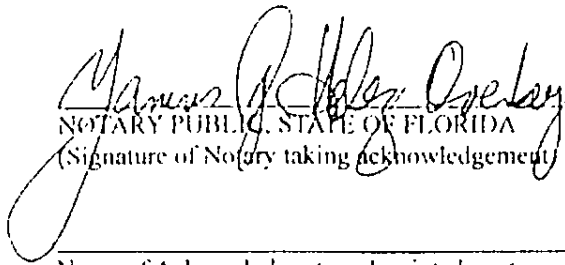
1. In April 2024, I submitted to the Florida Division of Corporations Articles of Incorporation for a proposed Nonprofit Corporation.

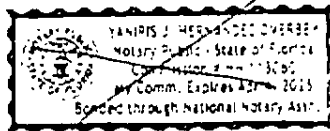
