# RESTATED AND AMENDED ARTICLES OF INCORPORATION OF Resurface Recovery Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

- 1. The name of the corporation is Resurface Recovery Inc.
- 2. The original Articles are being amended and restated. The text of the Amended and Restated Articles is as follows:

#### ARTICLE I NAME

The name of the corporation shall be: Resurface Recovery Inc.

### ARTICLE II PRINCIPAL OFFICE
