This corporation is established exclusively for charitable, religious and educational purposes within the meaning of the Internal Revenue Code section 501(c)(3), namely: to provide and promote Jewish knowledge, insight and awareness. It will accomplish these goals by establishing spiritual centers in the South Florida, in Israel and elsewhere, and there will be presented classes, courses, seminars and all manner of educational and social activities. These will promote the teachings, ideas and concepts contained in the Hebrew Scriptures, the Midrash, the Talmud, the Mystical texts and all subsequent commentaries and elaborations of the Rabbinic Traditions until the present day. This corporation will bring the great scholars and teachers of the generation to share their wisdom at the above-mentioned spiritual centers. It will plan, sponsor and implement works of charity and all other helpful services to the communities. It will provide support to Torah Scholars, who have put aside the many strivings of this life in order to dedicate themselves to studying and contemplating the Sacred texts of Judaism, and, by so doing, bringing great blessing into the world. It will likewise provide support to Jewish soldiers as well as any carrying out any additional activities which are seen by the directors as being helpful in enhancing the well-being of persons, families, and communities. In all its activities it will seek to inform and raise awareness about the great depths of the Torah's teachings, and call all people to finding closeness to G-d.

This corporation will not attempt to influence legislation or participate in political campaigns of any sort. No part of the earnings of this corporation will inure for the benefit of its directors or officers and it will not distribute dividends to anyone. However, it will pay reasonable compensation for services provided, work done, resources purchased, or properties acquired in order to carry out its mission. It will rent or purchase real property in order to provide a suitable facility for its activities.

Upon the filing of these articles with the Secretary of State, the Directors will be empowered to adopt bylaws and other related documents, to appoint corporate officers, to file forms with government agencies and to undertake any other action required for the operation of this corporation. The directors will adopt such decisions through in person meetings, telephonic communication, meetings via electronic media, written and signed consent, as well as by virtual signatures, all of which will be seen as equivalent to a vote cast at a meeting.
