The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

**ARTICLE II  
PRINCIPAL AND MAILING ADDRESS**

**ARTICLE III  
PURPOSE**

Any Amendment must be approved by the membership.
