ARTICLES OF INCORPORATION (Not for Profit) OF

THE SHALEM FOUNDATION, INC.

Article I - Name

The name of the Corporation shall be The Shalem Foundation, Inc.

Article II - Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this Corporation is organized is to spread the Gospel of Jesus Christ in parts of West Africa, including Togo and Ghana. The Corporation also recognizes that that basic healthcare needs are often deficient in parts of West Africa to the poor and distraught. Accordingly, the Corporation will seek to alleviate healthcare needs of the poor in parts of West Africa by performing the following: (1) screening services for those with metabolic diseases; (2) providing greater access to basic medications; (3) increase awareness to the general population on the prevention of metabolic diseases, and (4) provide training to healthcare professionals, including nurses, nursing assistants and medical assistants.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
