

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

The name of the corporation shall be CONGREGATION BRIGHT BEGINNINGS INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is:

- a. To conduct and maintain a House of Worship in accordance with the traditions of the Orthodox Jewish faith and to conduct all communal affairs necessary for viable community.
- b. To purchase and sell property, both real and personal. To mortgage and lease both real and personal property as may be necessary for the conduct and welfare of the corporation.
- c. Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- d. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- e. No party of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.
- f. No substantial part of the activities of the corporation shall be carrying on the propaganda, or otherwise attempting to influence legislation (except as otherwise provided by the Internal Revenue Code section 501(h), or participating in, or intervening in (including the publication of distribution of statements), any political campaign on behalf of any candidate for public office.

ARTICLE IV: MANNER OF ELECTION

The manner in which the directors are elected and appointed is as provided for in the bylaws.
