Pursuant to, and with the effect provided in, Section 617.1006 of the Florida Statutes and with the approval of the Corporation's incorporators the undersigned Corporation adopts the following Amended Articles of Incorporation as of 6/25/2024:

**ARTICLE I**

The name of the corporation (hereinafter referred to as the "Corporation") shall be:

**PURPOSE**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by a Board of Directors. The method of electing the Board of Directors shall be determined by the bylaws of the Corporation.

**ARTICLE VIII**

**LIMITATION TO CORPORATE POWERS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Sections 501(c)(3) of the code or the corresponding provision of any subsequent federal tax law.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

**ARTICLE VIII**

**(Continued and Amended to:)**

**LIMITATION TO CORPORATE POWERS**

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IX**

**(New Article)**

**TERM AND DISSOLUTION**

The Corporation shall exist perpetually or until dissolved by due process of the law. Upon the dissolution of the Corporation, the Board of Directors, after paying or making provisions for the payment of all the liabilities of the Corporation, assets shall be distributed to Centro Biblico Internacional Central Florida Assemblies of God, Inc., a Florida nonprofit corporation or to such organization or organization organized and operated exclusively for the exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


