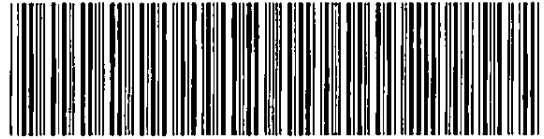

**ARTICLE I**

**NAME**

**The Name of This Corporation is: Kauffman International University, Inc.**

## ARTICLE III

### PURPOSES

**The general nature, object and purposes of this corporation shall be:**

- (a). For the purpose of promoting, establishing, supervising, and administering a Bible University, and ministry training center, teaching all matters pertaining to church worship and fellowship, church membership, Missionary outreaches, Religious seminars, International offices, church government, university and international church operation and training of such. These would be determined and stated in bylaws of the corporation, here, and authorized by these Articles of Incorporation.
- (b). To participate in and aid organizations, involved in Christian Outreach, Education and Evangelism.
- (c). Training and establishing aid for the disenfranchised.
- (d). This corporation is wholly a charitable organization.
- (e). To acquire by conveyance or inheritance – whether by gift or purchase – real property, private property, and mixed real and private property, to be received and held in trust for the use and benefit of this corporation and its stated purposes.
- (f). To improve, invest, sell, lease, assign, mortgage, or otherwise encumber any such property, when such an action is deemed to be in the best interest of the corporation as defined in its aforesaid stated purposes., as a Christian University Organization.
- (g). To market audio and video publications made and printed by this corporation for funding, offering scholarships, furthering the gospel and career training
- (h). To license and ordain qualified individuals for the gospel ministry, upon completion of required university course programs.
- (i). To operate and manage Radio and T.V. outreach and stations.
- (j). To solicit funds for each special project concerning the ministry on an organized giving plan.
- (k). To issue degrees of religious studies upon the completion of all requirements from: Associates of Religious Arts to Religious Doctorate under the guidelines of Florida State Board of Independent Colleges Statute, Chapter 246-083.

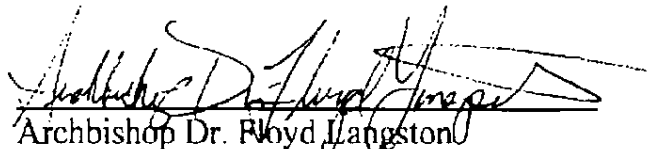

- b.) The above officers shall be the directors and trustees of the Kauffman International University, Inc. until the first election.
- c.) A Board of Regents will be appointed by the directors of this university to assist in the oversight of the functional programs of the university and its varied outreaches, and under the direct authority of the Board of Directors.
- d.) All trustees and directors shall be elected and appointed annually at the annual meeting, which shall be the first Monday of February each and every year at a time and place prescribed in the bylaws. Said officers and directors shall assume their duties and responsibilities at the first meeting following their election or appointment.
- e.) A majority of the directors shall constitute a quorum at any meeting of the directors.

## Article VII

### OFFICERS

- a. The business affairs of this corporation shall be managed by and under the supervision of the three directors/trustees, as set forth in the bylaws of this Corporation, which shall appoint a Board of Regents to oversee the operation of the corporation under the authority of the Executive Board.
- b. This corporation shall have a minimum of three director/trustees, who shall function as its board of directors initially. The number of the director/trustees may be increased from time to time as set in the by-laws but shall never be less than three.

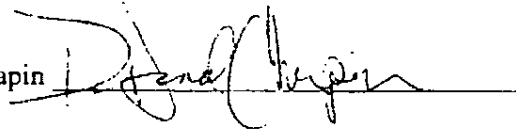

## Article XII

### LIMITATIONS AND DISSOLUTIONS

- (a) Kauffman International University, Inc. is organized exclusively for charitable, religious educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the Internal revenue Code of 1954 (or for corresponding provision of any future U.S. internal revenue law).
- (b) Notwithstanding any other provision of these articles, this corporation will not execute any other activities not permitted to be engaged by:
- a. A corporation exempted from Federal Income Tax under section 501c3 of the Internal revenue law; or
  - b. A corporation's contributions to which are deductible under section 170c2 of the Internal revenue Code of 1954 of the corresponding provision of any future U.S. Internal revenue law.
  - c. In the event of dissolution of Kauffman International University, Inc.. The residual assets of this corporation shall be given and signed over to another non-profit corporation as determined by the Board of Directors, one being that described by sections 501C3 and 170C2 of the Internal Revenue Code of 1954. Or the corresponding provision of any future US Internal Revenue law.
