This corporation is established exclusively for charitable purposes within the meaning of the Internal Revenue Code section 501(c)(3), namely: to provide our nation's veterans, service members, and their families — those who stood in the gap for us — with stable and successful futures. We believe in honoring their sacrifices by supporting them through every stage of their post-service lives. Whether they need emotional, spiritual, physical, or financial assistance, we are committed to providing the necessary resources and tools to help them thrive.

In addition to our primary mission, we are committed to enhancing the well-being of veterans, service members, and their families through charitable works. This includes activities to foster community support, provide educational opportunities, and ensure access to essential services. Our organization aims to create a supportive environment that promotes growth, prosperity; and dignity for those who have served our nation.

This corporation will not attempt to influence legislation or participate in political campaigns of any sort. No part of the earnings of this corporation will inure for the benefit of its directors or officers and it will not distribute dividends to anyone. However, it will pay reasonable compensation for services provided, work done, resources purchased, or properties acquired in order to carry out its pomission. It will rent or purchase real property in order to provide a suitable facility for its activities. The incorporator of this corporation will serve as its president at any time he sees fit to do so.
