

This corporation is established exclusively for charitable purposes within the meaning of the Internal Revenue Code section 501(c)(3), namely: to extend a helping hand to those facing hunger and homelessness in our community. We prioritize providing essential resources such as food, shelter, and educational opportunities to individuals in need. Additionally, we aim to nurture spiritual growth by offering support and guidance to develop faith in God. We understand the challenges and hardships faced by individuals experiencing homelessness, and we are deeply invested in offering practical assistance and support. By addressing immediate needs and fostering a sense of hope and belonging, we aim to empower individuals to overcome adversity and build brighter futures for themselves and their communities. Moreover, we are dedicated to assisting the poor, the distressed, or the underprivileged; thereby lessening neighborhood tensions; eliminating prejudice, and overcoming discrimination.
