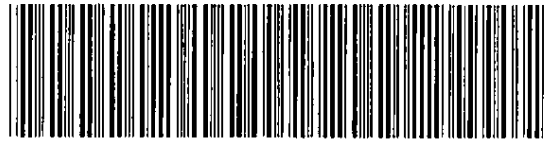

making distributions to other organizations under section 501(c)(3) of the Internal Revenue Code or corresponding

support to the domestic violence community in relation to keeping their pets safe, and will provide sanctuary to other

at risk domestic animals.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.
