

Articles of Amendment to Articles of Incorporation

Beulah Farmers Market, Inc.

The Articles of Incorporation for this Not-for-profit Corporation were filed on August 5, 2024 and assigned Florida Document Number N24000009353. This Amendment is submitted to amend the Articles of Incorporation in their entirety and replace them as follows

Article I Name

The name of the Corporation is Beulah Farmers Market, Inc.

Article II Principal Office

The principal mailing and street address is 10715 Beulah Rd., Pensacola, FL 32526.

Article III Purpose

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to Incorporations that qualify as exempt Incorporations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The company's primary focus is to stimulate local economies, increase access to fresh food, support healthy citizens and sustainability to preserve America's rural livelihoods.

Article IV Manner of Election

The manner in which the members are elected or appointed is provided in the bylaws of the company.

Article VI Limitations

No part of the net earnings of the company shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the company shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this company shall not carry on any other activities not permitted to be carried on (a) by a company exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a company, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII Dedication of Assets

Upon the dissolution, termination, or winding up of the company, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such Incorporation or Incorporations, as said Court shall determine, which are organized and operated exclusively for such purposes.
