

ARTICLES OF INCORPORATION

ARTICLE | NAME

The name of the Corporation shall be **The Salvation Army Bahamas, Inc.**, (hereinafter referred to as the "Corporation") a not for profit corporation organized under the Florida Not For Profit Corporation Act set forth in Chapter 617, Florida Statutes.

ARTICLE II PRINCIPAL OFFICE

Principal street address of the Corporation:

ARTICLE III PURPOSE

This Corporation is organized and shall be operated exclusively for charitable, educational, religious, and literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (hereinafter referred to as the "Code") including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code, or the corresponding section of any future tax code.

The purpose of this Corporation is to enable organizations like The Salvation Army of The Bahamas and the Turks and Caicos in those regions to become effective transformation agents in their communities. The mission of the corporation is to raise funds and provide financial support for the construction and operation of a women's shelter in The Bahamas. Through this financial support, the Corporation hopes to support and enhance the overall operations of the organization in The Bahamas for them to better serve the community.

The Corporation shall accept gifts, donations and endowments, and have the power to make gifts, grants, expenditures and endowments for or to any charitable, scientific or religious undertaking, organization, institution or purpose anywhere in the world that meets the tax-exempt requirements of 501(c)(3) section of the Code.

ARTICLE IV NOT FOR PROFIT NATURE

The Salvation Army Bahamas Inc. Articles of Incorporation

- (a) The Salvation Army Bahamas Inc. is organized exclusively for charitable, scientific or religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations as defined in §501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 (the "IRC" or the "Code") or the corresponding provisions of any future, United States internal revenue law, including without limitation, the purposes, stated in its articles of incorporation and the following purposes, but only to the extent that they are within the scope of such exempt purposes;
- (b) No director, officer, or any other private individual should receive at any time any of the net earnings or pecuniary profit from the operations of the corporation. No loans shall be made by the corporation to its directors or officers. No director, officer or any other private individual shall be entitled to share in the distribution of any of the corporate assets upon the dissolution of the Corporation, provided that this shall not prevent the reimbursement of expenses incurred by such persons for and on behalf of the Corporation and the payment of reasonable compensation for services rendered to or for the Corporation as shall be approved by the Board of Directors. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- (c) All directors and officers of the Corporation shall be deemed to have expressly consented and agreed that upon dissolution or winding up of the affairs of the Corporation, whether voluntary or involuntary, after compliance with all applicable laws, the assets of the Corporation then remaining in the hands of the Board of Directors shall be transferred, conveyed, delivered and paid over for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V MANNER OF ELECTION

Directors shall be appointed or elected as indicated in the bylaws of the corporation.
