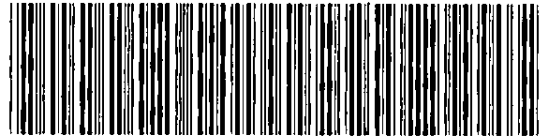

Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation is: Archangel Foundation, Inc.

Article II Principal Office

The principal street address is 101 Aragon Ave., Unit 1, Coral Gables, FL 33134.

The principal mailing address is 101 Aragon Ave., Unit 1, Coral Gables, FL 33134.

Article III Purpose

The Corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that engage in charitable, educational and scientific activities, including but not limited to providing assistance and support to youth education; public and individual health initiatives, research and development of therapeutics and medical devices; and green energy and related environmental and conservation initiatives, including research and development of green energy initiatives. The Corporation shall also be empowered to provide other charitable and educational support as determined by its Board of Directors, including support of other organizations that are qualified as tax-exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV Manner of Election

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.




