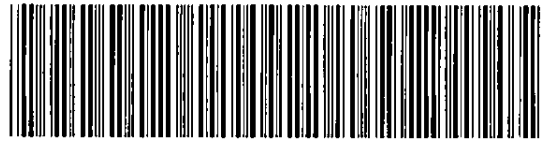

**ARTICLES OF INCORPORATION  
(Not for Profit)

**Article I – Name**

The name of the Corporation shall be Friends of the Care Project USA, Inc.

**Article II – Address of Corporation**

The principal address of the Corporation and the mailing address shall be:

**Article III - Purpose**

The purpose for which this Corporation is organized is to provide funding support to a foreign charitable nonprofit known as, Friends of the Care Project USA, Inc. ("Antiguan Nonprofit"), which entity is organized under the laws of Antigua and Barbuda. The Corporation will raise funds in the United States to provide monetary support to aid the activities of the Antiguan Nonprofit. The Antiguan Nonprofit's activities are intended to improve the quality of life of children and young adults who are afflicted with mental or physical disabilities through education, therapy and skills training.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**Article IV – Manner of Election**

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
