**ARTICLES OF INCORPORATION OF VILLAGE OAKS POINTE
HOMEOWNERS' ASSOCIATION, INC., a Florida non-profit
corporation**

The undersigned incorporator by these articles associates himself for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopts the following articles of incorporation:

**ARTICLE I
NAME**

The name of this corporation is Village Oaks Pointe Homeowners' Association, Inc. For convenience, the corporation shall be referred to in this instrument as the "Association," these articles of incorporation as the "Articles," and the bylaws of the Association as the "Bylaws."

**ARTICLE II
TERM OF EXISTENCE**

The Association shall have perpetual existence.

**ARTICLE III
CORPORATE PURPOSE**

This association is organized for the purpose of providing a non-profit entity under the Florida Statute Chapter 617 (2023) ("the Statute") for the operation of the residential homeowners' association for various parcels located in Okaloosa County, Florida.

BYLAWS**

The association shall be governed by Bylaws.

**ARTICLE X
STORMWATER MANAGEMENT SYSTEM**


1. If required, the Association shall operate, maintain and manage the stormwater management system in a manner consistent with the requirements of Northwest Florida Water Management District and applicable Agency rules, and shall assist in the enforcement of the restrictions and covenants contained herein.
2. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the stormwater management system.
3. The assessments shall be used for the maintenance and repair of the stormwater management systems and mitigation or preservation areas, including but not limited to work within retention areas, drainage structures and drainage easements.

4. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the stormwater management system (if any) must be transferred to and accepted by an entity which complies with the Florida Administrative Code and be approved by the Agency prior to such termination, dissolution or liquidation.

5. Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.
