ARTICLES OF INCORPORATION OF

A Florida Non-Profit Corporation

These articles of incorporation are signed by the incorporator for the purpose of forming a corporation not for profit under the provisions of Florida Statutes. Chapter 617, as follows:

ARTICLE I. - NAME

The name of this corporation is FATHER'S DESTINY INTERNATIONAL, INC. The principal office and the mailing address of the corporation is 1111 3rd Ave W. Bradenton, FL 34205.

ARTICLE II. - MISSION STATEMENT; PURPOSE

The corporation exists to enhance the lives of those in need, providing the service and support they cannot provide themselves, in a manner pleasing to God. The corporation has initially established sustainable projects in African countries beginning with Uganda. Funding raised from the corporation's donors will assist in eradicating poverty for widows and needy families. The corporation provides support for small scale businesses for single mothers. The corporation's educational projects provide school supplies where none are currently available. Farming projects of the corporation include local food for families and the farming of trees to financially supplement gifting. The corporation provides food support for children.

The corporation is organized and shall be operated exclusively for charitable, educational, and scientific purposes, including, but not limited to:
