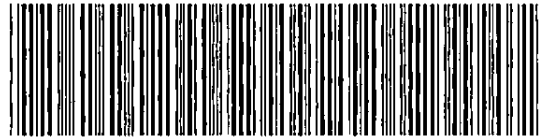

ARTICLES OF INCORPORATION
OF
ANCHOR PRESBYTERIAN CHURCH OF COLLIER, INC.

Pursuant to Section 617.0202, Florida Statutes, and the laws of the State of Florida, the following Articles of Incorporation of Anchor Presbyterian Church of Collier, Inc., a Florida not-for-profit corporation, are hereby adopted, as set forth herein.

These Articles of Incorporation ("**Articles**") were duly adopted in the name of God by the Trustees named below, effective as of September 11, 2024, and the number of votes cast for approval of these Articles was sufficient.

ARTICLE I. NAME AND ADDRESS

The name of this Florida not-for-profit corporation shall be "Anchor Presbyterian Church of Collier, Inc.", herein referred to as the "**Church**". The principal office and mailing address of the Church shall be 6926 Trail Blvd., Naples, Florida 34108.

ARTICLE II. PURPOSE AND POWERS

The object and purpose of the Church shall be to worship God and proclaim the Gospel of Jesus Christ in accordance with the doctrinal, governmental, and disciplinary standards of the Presbyterian Church in America, as more particularly set forth in the Bylaws of the Church ("**Bylaws**"). The Church shall have all powers set forth in the Bylaws and Chapter 617, Florida Statutes.

ARTICLE III. MEMBERSHIP

Membership in the Church is open to any person upon the recommendation of, and by vote of, the Session, as more particularly set forth in the Bylaws.

ARTICLE IV. TERM; DISSOLUTION

- A. **Term**. The term of the Church shall be perpetual.
- B. **Dissolution**. Any dissolution of the Church shall be in accordance with the applicable provisions of the Bylaws and Chapter 617, Florida Statutes.

ARTICLE V. BOARD OF TRUSTEES AND SESSION

- A. **Board of Trustees**. The affairs of the Church shall be conducted and governed by a Board of Trustees ("**Trustees**"). The Trustees, as corporate officers of the Church, shall be members of, and elected annually by, the Session, all in accordance with the Bylaws. The Trustees shall have charge of all Church property, real and otherwise, and shall be entrusted with such responsibility as provided in the Bylaws and Chapter 617, Florida Statutes. The names, titles, and addresses of the current Board of Trustees are as follows:

B. Session. The governing body of the Church shall be the Session. The Session shall be comprised of, and its members elected in accordance with, the provisions of the Bylaws.

ARTICLE VI. BYLAWS

The Bylaws shall be adopted by the Session and may be altered, amended, or rescinded in the manner provided therein.

ARTICLE VII. AMENDMENT

Any amendment, rescission, or revision of these Articles shall be accomplished by a two-thirds majority of the members of the Church present and voting at any meeting duly-called for such purpose. Notice of said meeting shall be provided to the members of the Church by announcement from the pulpit during all worship services not less than fourteen (14) days prior to the date of the meeting and, in the judgment of the Session, communicated to the members of the Church through usual and ordinary channels of communication.

ARTICLE VIII. REGISTERED AGENT AND OFFICE

The registered agent of the Church shall be Brian Hill, and the street address of the registered office of the Church is 6926 Trail Blvd., Naples, Florida 34108. The Church shall have the right to change such registered agent and office from time to time as provided by law.

ARTICLE IX. INCORPORATORS AND ADDRESSES

The incorporators of the Church shall be Brian Hill, Marvin Schoenhals and Mark Barineau. The street address for each of the Incorporators is 6926 Trail Blvd., Naples, Florida 34108.
