

AMENDING:

Article III

The Corporation is a Florida not-profit corporation organized exclusively for, and limited to one or more, exempt charitable, religious, educational and scientific purposes, as defined within section 501(c)(3) of the IRS code, including for such charitable purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the IRS code, or corresponding sections in any future federal tax code section.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The corporation shall not carry on any activities that in themselves are not in furtherance of one or more exempt purposes.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 50I(c)(3) of the IRS Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under 170(c)(2) of the IRS Code, or corresponding section of any future federal tax code.

ADDING:

Article IX

Upon the dissolution of the corporation, its assets shall be distributed for one or more exempt purposed within the meaning of section 501(c)(3) IRS Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation operates, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

Article X

The corporation will not engage in any act of self-dealing as defined by Section 4941 of the IRS Code, or corresponding section of any future federal tax code.

Article XI

The corporation shall not retain any excess business holdings as defined by Section 4943(c) of the IRS Code, or corresponding section of any future federal tax code.

Article XII

The corporation shall not make any investments in such manner as to become subject to the tax on undistributed income proposed by Section 4944 of the IRS Code, or corresponding section of any future federal tax code.

Article XIII

The corporation shall not make any taxable expenditures defined by Section 4945 of the IRS Code, or corresponding section of any future federal tax code, taxable expenditures include attempting to influence legislation or carrying on propaganda
