Article 1.

The name of the corporation is Sowing Somewhere Inc

Article 2.

The initial registered office of the Corporation shall be at: 13913 SW 171st PL, Archer Florida 32618. The initial registered agent of the Corporation at such address shall be: Inga Fowler.

Article 3.
