ARTICLES OF INCORPORATION

ARTICLE I NAME

1. Name

The name of this corporation shall be Pure And Free Inc. The business of the corporation may be conducted as Pure And Free Inc. or Pure And Free.

ARTICLE II LOCATION

2.01 Location

The principal place of business is 435 12th Street West Suite 204, Bradenton, FL 34205. The mailing address of the business is 435 12th Street West Suite 204, Bradenton, FL 34205.

ARTICLE III PURPOSE

3.01 Purpose

Pure And Free Inc. is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. The purpose of this organization is to provide resources, services, and support for those in the community who suffer from sexual addiction and the mental health-related problems associated with this type of behavior.

3.02 Non-Profit

Pure And Free Inc. is designated as a non-profit corporation.

ARTICLE IV NON-PROFIT NATURE

4.01 Non-profit Nature

Pure And Free Inc. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of

furtherance of the purposes set forth in Article III, Section 3.01.

4.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

Board of Directors

5.01 Governance

Pure And Free Inc. shall be governed by its board of directors.

5.02 Manner Of Election

Pure And Free Inc.'s directors will be elected by the board of directors.

5.03 Initial Directors

The initial directors of the corporation shall be Cameron Gamso, Kelsey Gamso, and Lisa Muccio.

ARTICLE VI

MEMBERSHIP

6.01 Membership

Pure And Free Inc. shall have no members. The management of the affairs of the corporation shall be vested in a board of directors, as defined in the corporation's bylaws.
