

Attachment to Articles of Incorporation of MROD FOUNDATION, INC

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions toorganizations that qualify as exempt organizations under section 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code. This -- corporation shall be a nonprofit corporation. Specifically, this corporation will focus on raising and donating charitable contributions to the areas of education for children in need and improving the lives of those who are suffering without clean drinking water, $\overline{\overline{n}}$ primarily in third world countries. The foundation will also raise and donate fundsito help cover the costs associated with medical procedures, provide medication, or 🗂 support of those undergoing cancer treatment. The foundation will help in the supply of clean drinking water through the drilling of wells and directing water to a water treatment and purification plant, as well as the subsequent distribution. The foundation will also target the development of a network of wells which will provide irrigation for agricultural purposes. Another aspect of the operational purpose of the foundation is to raise funds to build additional classrooms in schools to alleviate overcrowding and therefore enhance the learning experience for the students who are currently at a disadvantage.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue

Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
