

#### CERTIFICATE OF DOMESTICATION FORWARD FREE, INC.

The undersigned hereby files this Certificate of Domestication pursuant to Section 617.1803, Fla. Stat. (2024) with respect to Forward Free, Inc. (the "Corporation") under the laws of the State of Florida as follows:

#### ARTICLE I Original Incorporation Date and Jurisdiction

The Corporation was first incorporated on March 28, 2016 in the State of Minnesota.

#### ARTICLE II Names

The name of the Corporation immediately before the filing of this Certificate cof Domestication was Forward Free. The name of the Corporation, as set forth in its Florida articles of incorporation is Forward Free, Inc.

#### ARTICLE III Jurisdiction Prior to Filing

The jurisdiction that constituted the seat, siege social, or principal place of business or central administration of the Corporation immediately before the filing of the certificate of domestication was the State of Minnesota.

## ARTICLES OF INCORPORATION OF FORWARD FREE, INC.

The undersigned incorporator to these articles of incorporation hereby forms a corporation not for profit (the "Corporation") under the laws of the State of Florida as follows:

### ARTICLE I Name, Principal Place of Business, and Mailing Address

The name of the Corporation is: Forward Free, Inc. The principal place of business address is: 17206 Fountainside Loop #6112, Lutz, FL 33558. The mailing address is P.O. Box 1262, Odessa, FL 33556.

### ARTICLE II Purpose

The Corporation is organized and shall be operated exclusively for charitable, religious, and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code"), including, but not limited to, providing practical help to law enforcement officers, emergency service personnel, and disabled veterans while seeking opportunities to share the gospel.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objects. All of the assets or earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. No part of the net earnings shall inure to the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

### ARTICLE III Members

The Corporation shall not have any members.

### ARTICLE IV Registered Office and Agent

### ARTICLE X Limitations

- Section 1. <u>Legislative and Political Activity</u>. No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements in connection with) any political campaign on behalf of or in opposition to any candidate for public office.
- Section 2. <u>Property</u>. The property, assets, profits, and net income of the Corporationare dedicated irrevocably to the purposes set forth herein. No part of the Corporation's profits or net earnings shall inure to the benefit of its directors, officers, members, or to the benefit of any private individual.
